## WEST TRAVERSE TOWNSHIP REGULAR BOARD MEETING DECEMBER 10, 2019

Supervisor Sandford called the meeting to order at 6:00 p.m.

Roll Call: Baker, Lauer, Hollingsworth, Sandford, Baiardi.

Visitors: Tom Varner, Paul Mooradian, Jim Bartlett.

The Pledge of Allegiance was recited by all.

<u>Approve Agenda and Additional Items</u>: The agenda was approved by consensus.

Public Comments: None.

<u>Approve Minutes</u>: Baiardi made a motion to approve the meeting minutes of November 12, 2019 as presented. Hollingsworth seconded the motion. Vote: All yes.

<u>Correspondence</u>: The correspondence was reviewed. There was discussion regarding the Hoyt Road trail and keeping non-motorized traffic off the trail since part of it is on private property. It was decided to use ropes at the easy access points (Quick Rd. corner, subdivision entrances) and also to install signs on some of the posts stating that this is a non-motorized trail.

<u>Appointments</u>: Sandford made a motion to appoint Jim Bartlett as an alternate for the Board of Review, effective 12/10/19, for the remainder of the term expiring 12/31/20. Baker seconded the motion.

Sandford made a motion to re-appoint Paul Repasky as a regular member of the Planning Commission, effective 1/1/20, for the 3-year term expiring 12/31/22. Lauer seconded the motion.

Sandford made a motion to appoint Tom Varner as a regular member of the Planning Commission, effective 1/1/20, for the 3-year term expiring 12/31/22. Baker seconded the motion.
