Supervisor Bartlett called the meeting to order at 6:00

Approval of Agenda and Additional Items: Approved by consensus.

Public comments: Moore thanks the Board for having him on the Planning Commission again.

<u>Approval of Minutes</u>: Baiardi moved to approve the minutes as presented. Bartlett seconded the motion.

Approved by consensus. Hollingsworth abstained as she was absent for the December meeting.

Correspondence: Correspondence was reviewed.

Action on rezoning request: Bartlett reviews the rezoning request from Michael Woodham, case 02-2021. Bartlett states the Planning Commission denied the request, so now it comes to the Township Board for action and to make a final decision on it. Mooradian discusses the memo from the County and states that at some time we need to allow some growth to keep this community thriving, but she agrees with the decision of the Planning Commission. Hollingsworth states she is on the fence with it and feels the storage units would be a great buffer between commercial and residential. Hollingsworth continues, if the Planning Commission denied it based on the Woodhams could do whatever they want once it is rezoned commercial, she would have to agree with that denial. Hollingsworth states if they had approved it based on a conditional use specifically for the storage, then she would agree with that. Mooradian makes a motion to deny zoning change on parcel 16-15-12-100-031, case 02-2021. Bartlett seconds the motion.

<u>Supervisor</u>: Bartlett states he does not have the Cross Connection Contract or the Fire Department year-end report yet but will include it in next month's packet if received. Bartlett states "we continue to work to review Breckenridge Farm's documents in light of their request to submit a new special use permit, to provide lessons, and become more commercial." Bartlett states "*After review by the Township Attorney*, it is clear that the 1996 District Court Order forbids any use of that property other than private and non-commercial use." Bartlett states "the order supersedes any of the Township activities that have happened over there." Bartlett continues, "if the farm wants to change the use they will need to go to the court, open that case, and convince the court of what they want to do". Bartlett states he has communicated that to the owner.
